A natural, agricultural approved de-icing product (sugar beet or approved equivalent) that is less corrosive than traditional chlorides and that is less harmful to the environment. The product should demonstrate passing limits that the Pacific Northwest Snow fighters require for deicers to be used in their states. The deicer should have a freeze point of at least -30 degrees F below zero. The deicer should be biodegradable and non-toxic to humans and animals. The product should be acceptable for use as an inhibitor for salt brines and thus be able to be blended with all salt solutions without stratification. Product should be able to be used as an, admix for salt stockpile mixing to prevent freezing without leaching. The material should have a minimum concentration of 55% and have a minimum viscosity of 30cP at 30 degrees F.

The product should have less than 2% chlorides content (as chloride) and any chloride present must be naturally occurring in the product, not added to the natural deicer. The approved products contents shall be fully disclosed to the McHenry County DOT. No priority products can be approved without full disclosure.
