- No shipping costs will be paid for materials purchased. All shipping costs for material purchased must be included in the unit bid price for those items.
- Unit prices must remain in effect until November 1, 2025
- Bidders may bid on any or all groups. Bidders are not required to bid on all groups. The award(s) will be made to the lowest responsible, responsive bidder by group. There may be multiple awards
- All quantities listed in the Schedule of Prices are estimated quantities only. The County makes no promise of

Group 1: U-CHANNEL POSTS & POST POUNDER ADAPTER:

McHenry County currently uses:

• 2" Xccessories Squared channel and post clamps

2" Sign Channel:

- Overall dimensions -2" mounting surface x 7/8" depth x 1/8" nominal wall thickness 6061-T6 aluminum alloy. Material shall be delivered in 10' (foot) lengths
- 2" channel shall be Xccessories Squared ASB200 or equivalent

1-1/4" Sign Channel:

- Overall dimensions $-1 \frac{1}{4}$ " mounting, 6061-T6 aluminum alloy. Material shall be delivered in 10' (foot) lengths
- 2" channel shall be Xccessories Squared ASB125 or equivalent

8' long baked on enamel green U-channel sign posts, (IDOT Type C) of varying lengths indicated on the proposal, weigh 2 lbs. per foot, holes 3/8" in diameter 1-inch from the top on 1-inch centers for a minimum of 18" per IDOT Highway Standard 720011-01 and the requirements of section 1006.29 of IDOT's Standard Specifications for Road and Bridge Construction (2016).

The quantities of the above items are listed in the Schedule of Prices. The successful bidder shall make delivery within "30" days upon receipt of order. Deliveries shall be made before 2:00 PM CST on any weekday. All deliveries shall be made within "30" days upon receipt of any order. Deliveries shall be made before 2:00 PM CST on any weekday. All posts are to be delivered to the County Yard.

Group 2: ALUMINUM BLANKS

The sign blanks material shall conform to the section 1090 of IDOT's Standard Specifications for Road and Bridge Construction (2016). The sign blanks up to and including 9 square feet in area shall be type 1: 0.080+or-gauge sheet aluminum with a tolerance of +or-0.004. The sign blanks over 9 square feet in area shall be type 2: 0.0125+or-gauge sheet aluminum with a tolerance of +0.007.

Any exceptions to the gauge thickness of the blanks stated above shall be listed in the schedule of prices for a specific blank.

Domestic metal shall be used. All other blanks shall have 3/8-inch diameter mounting holes shall be drilled as per enclosed diagrams except as noted on the diagram sheets. The supplier shall furnish a one square foot sample of the metal together with a certificate that the sign blanks are made from the same lot or heat number of metal represented by the sample. If more than one lot or heat number is involved, a one square foot sample shall be furnished for each lot or heat number.

All deliveries shall be made within "30" days upon receipt of any order. Deliveries shall be made before 2:00 PM CST on any weekday.

Group 3: SIGN MATERIAL ROLL GOODS

General - All reflective sign sheeting used for traffic control highway signs shall be **3M TCM sign material** and at a minimum shall meet the requirements of sections 1091 and 1092 of IDOT's Standard Specifications for Road and Bridge Construction (2016).

The type of sheeting and quantities are listed in the schedule of prices. All roll goods supplied shall come with a **clear plastic liner**.

All deliveries shall be made within <u>"30" days</u> upon receipt of any order. Deliveries shall be made before 2:00 PM CST. on any weekday.

Group 4: SIGN FACES

No text (company initials, agency name, etc.) will be allowed on the front of the sign faces or in the borders, etc.

All deliveries shall be made within <u>"30" days</u> upon receipt of any order. Deliveries shall be made before 2:00 PM CST on any weekday.

Group 5: ROLL UP WARNING SIGN ASSEMBLY

All roll up warning sign shall conform to the following specifications. The 48" x 48" roll up sign assemblies shall be composed of <u>3M Scotchlite Diamond Grade Fluorescent Orange reflective roll up sign material</u>, fiberglass crossbracing (minimum 1½" thickness), NO WARNING FLAGS SHALL BE MOUNTED TO THE CROSSBRACING. The roll up sign shall have a pocketing system to accept the crossbracing.

The 36" x 36" roll up sign assemblies shall be composed of 3M Scotchlite Diamond Grade <u>Fluorescent Orange</u> reflective roll up sign material, fiberglass crossbracing (minimum 1½" thickness). Roll up Flag Bags shall hold two roll up flags each of the 36" roll up flags.

Roll up flag bases must be Economy MDI Sign Stand, Duralatch Only 5012NSAL or equivalent, (**Aluminum only no exceptions**).

All deliveries shall be made within <u>"30" days</u> upon receipt of any order. Deliveries shall be made before 2:00 PM CST on any weekday.

Group 6: SIGN MOUNTING HARDWARE

All steel bolts, nuts, and washers shall be Silver Zinc, USS Grade 5. Domestic steel shall be used for sign mounting hardware. The quantities of the above items are listed in the Schedule of Prices.

The Serrated Flange Nut should have a flange diameter of approximately 0.675" and a nut diameter of 0.5.

All deliveries shall be made within "30" days upon receipt of any order. Deliveries shall be made before 2:00 PM CST on any weekday.

Group 7: TRAFFIC CONTROL DEVICES

All Type III barricades shall have 1.75" (O.D.), Telespar steel post uprights with angle iron feet to match post size. Red H.I.P. panels 1"x8"x10" plastic. 50% of quantity shall be left hand barricades, and 50% shall be right hand barricades, hardware to attached panels included.

The Red and Orange 10' Type III Panels shall be 1"x8"x10', (no hardware included)

Tuff Curb Lane Separator IR TUFF CURB WHITE END CAP MASH PASSED or equivalent. Hardware to attach to pavement shall be included.

Tuff Curb LANE SEPARATOR IR TUFF CURB WHITH/QUICK RELEASE/WH-WH 2WAY REFLECTOR MASH PASSED or equivalent. Hardware to attach to pavement shall be included.

Tuff Curb IR MULTI-PURPOSE TBLR MKR 2.375"OD/36" L/WH/2 WH HIP/OPEN W/BK CAP/QR or equivalent.

36" Round White Plastic Hard surface mount Delineator with base (2023) ND360 surface mount tubular marker 2.25"OD/36"L/YE/2 YE Hip bands(10/box) Mash Passed or equivalent.
