**CORRESPONDENCE:** A letter was received from Huntley Fire Protection District thanking the ETSB Staff for their assistance with Huntley Fire's router changes.

FINANCIAL: The ETSB FY08-09 Budget was presented to the Law and Justice Committee of the McHenry County Board for review.

**TECHNICAL:** Art, Jim, and Ryan attended the National Apco Conference in Kansas City, MO. Their primary focus was to review CAD and RMS vendors. They also met with Net Motion representatives, and will be hosting a demo in September.

**PERSONNEL**: Chief Rydberg informed the board he would like to have the employee evaluations to him by the end of September for review.

**TRAINING**: Wileen advised the dates for EMD class has been scheduled for October 16, 23, 30, and November 6 and 13. Please get names of TC's needing training to the ETSB office.

Sgt. Johns presented preliminary pricing to the board for new EMD, FIRE, and POLICE dispatch books. The quote from Priority Dispatch was over \$500,000 for all new training and materials. Powerphone provided a cost of \$10,588 for 26 sets of books. He and Wileen met with Cindy Amore to go over EMD continuing education requirements. The time is 32 hours over a 4 year period. They will be preparing, submitting, and implementing their con-ed plan. There was additional discussion of APCO Institute's online / CD courses.

PSAP: The new PC's will be arriving over the next few weeks, and will be installed at the PSAP's soon.
