### EXPLANATION OF PROJECT CLOSE OUT FEES

#### **FINAL INSPECTION FEES (Performance Guarantee)**

**\$ 500** First official final inspection of the completed construction, for the release of the Performance Guarantee, plus one (1) follow-up inspection after a punch-list is created. This equates to the 1st inspection and 2nd inspection, if necessary, for the roadway improvements.

**\$ 250** For each of the 3rd or more inspections, if necessary.

The **\$ 500** final inspection fee is due no later than submittal of the Resident Engineer letter that indicates the work has been completed and requests an inspection from MCDOT. All other final inspection fees are due before each of those inspections would be done and before the Performance Guarantee would be released by MCDOT.

#### **FINAL INSPECTION FEES (Maintenance Guarantee)**

**\$ 250** First inspection for release of the Maintenance Guarantee.

**\$ 50 (each)** For each of any follow-up inspections required after the 1st Maintenance Guarantee inspection.

The **\$ 250** Maintenance Guarantee inspection fee is due no later than when a request for release of the Maintenance Guarantee is made. All other fees are due before each of those inspections would be done and before the Maintenance Guarantee would be released by MCDOT.
