Bituminous mixtures are not required to be purchased from an IDOT AGCS certified source, however, the aggregate utilized in the mix must be IDOT AGCS certified. Aggregate products which are not IDOT AGCS source certified will not be compensated for under this authorization. All products shall include but are not limited to the following: bituminous mixtures, all aggregates and recycled asphalt. Material tickets for aggregate and recycled asphalt shall come directly from the certified source. Material from yard stockpiles of a non-source certified location is unacceptable. Invoices submitted without load tickets will not be compensated for. All bituminous load tickets shall be printed by a computerized printer or the vendor and/or homeowner's association will not be compensated. It shall be the homeowner's association's responsibility to submit the appropriate information to the McHenry County Division of Transportation.
