Mr. Chirikos reminded the Commissioners to prepare their annual reports and turn them in by the end of the month.

#### Survey

Mr. Randall stated he will contact Ms. Brown to see how she puts together her annual report.

#### **Municipal Liaison**

Ms. Mack submitted her report in writing and it is attached to these minutes. She attempted to contact Catherine O'Connor regarding the Joint Council meeting, but her email bounced back. She will try and contact her again.

The Barber Cemetery will be landmarked on April 17<sup>th</sup>. Invitations have been sent. #### **Old House Resources**

#### **Victory Gardens**

Ms. Selpien reported she is trying to schedule a meeting with the volunteers from the County to start planning the garden. There are ten people who volunteered. Ms. Selpien said she is looking into getting a deer fence. Ms. Wanaski volunteered to call the City of Woodstock to inquire about their requirements for fences.

#### Old House Support Group

Mr. Chirikos researched Grace Hall in Woodstock and demolition permits have not yet been issued but it is inevitable. There is a group of individuals who are trying to have the demolition reversed, and they are working with a group that is proposing the site as a local landmark.

All work done on homes and homes "child occupied" buildings built prior to 1978 will require workers to be certified by the EPA. This goes into effect on April 22, 2010 and this is important for people who repair and rehabilitate historic structures.

Mr. Chirikos submitted an article from the January issue of the *Eco-Structure* Magazine which is attached to these minutes. The article discusses the need to recognize common areas of interest and goals which the preservation community shares. He encouraged everyone to read the article once it is distributed with the minutes.

#### Call to Order

Mr. Chirikos called the meeting to order at 7:03 p.m.

#### **Approval of Minutes**

Mr. Chirikos pointed out that under Old House Support Group, the last sentence should read "local landmark" instead of "national landmark". It was also noted that Mr. Gervais was not present at the meeting. Ms. Brown would like County designations shown on the *Sites by Plaque Number* handout.

Motion by Mr. Gervais, seconded by Ms. Mack to approve the March 3, 2010 Historic Preservation amended minutes. All members present voting aye. Motion carried.

#### **Chairperson Report**

Mr. Chirikos submitted a written report and it is attached to these minutes. He attended the March 24th Joint Council meeting. He stated that Ms. O'Conner, from Illinois Historic Preservation Agency (IHPA,) remarked that of all the historic groups in Illinois, we are one of the few that has a council that is active and meets on a regular basis.

#### **Standing Committee Reports**

#### Survey

Ms. Brown submitted her annual report. Mr. Randall submitted his report in writing and it is attached to these minutes. He reported he has received two landmark nominations. The first property is located at 4112 County Club Road in Ridgefield. The house is owned by Karen Dominski. He is waiting to hear back from Ms. Dominski before he visits the property. The second property is the Alden Mill. The owner, Ms. Endres, would like to continue with land marking her property. Mr. Gervais left the room during this discussion due to a conflict of interest. Her house encroaches on the new right-of-way of Alden Road which is being widened. She submitted her Plat of Vacation to the Commission so they can proceed. The County has vacated their right to the land that runs in her living room.

Ms. Wanaski submitted another property for possible land marking to Mr. Randall. Mr. Randall discussed the possibility of having potential Eagle Scouts help with the rural intensive survey. He thinks it would be a great Eagle Scout project. The Commission discussed both the advantages and disadvantages of this. Ms. Wanaski questioned the

County's electronic policy and Ms. Doornbosch was concerned with sending minors out into rural areas. The possibility of having the scouts work in the office was also discussed.

Motion by Mr. Randall, seconded by Ms. Brown to research the feasibility of using the rural intensive project as an Eagle Scout project.

Ms. Wanaski would like to get clearance from the County regarding the electronic policy and Ms. Brown will arrange to get methodology for doing the survey.

All members present, with the exception of Ms. Doornbosch, voting aye. Motion carried.

Ms. Brown explained the MCCD policy that any structure they remove is photographed and documented and is sent to the Historical Society. Ms. Brown stated there are properties at MCCD that are slated for demolition. She submitted pictures and they are attached to these minutes. The first one is at Lusky-Marsh. The house is a 1930's house, the roof is in disrepair and water has been running through the middle of the house.

Property number two is at Rush Creek. It is a brick ranch house that has a driveway that has rotted railroad ties holding up the side of the driveway. The driveway is caving in and they estimate it will cost over \$20,000 to make it safe. MCCD has decided to take it down. The third house is in the Lake in the Hills fen on Randall Road. Both the barn and the house are falling down. Ms. Brown invited Mr. Chirikos to come visit the properties. He is upset that houses are being torn down that could be saved.

#### **Municipal Liaison**

Ms. Mack submitted her report in writing and it is attached. She attended the Joint Council meeting on March 24th and said it was very successful. She noted there will be a seminar on June 18th at the Dole Mansion. Ms. O'Connor will return and be one of the speakers.

The Barber Cemetery land marking ceremony is all set to go. Ms. Mack submitted the program information to Ms. Brown. Ms. Mack received a call from a Lieutenant Colonel from the 5<sup>th</sup> Armor Calvary. He and another soldier will present a flag on behalf of the United States and their Army Reserve Unit to the Barber family members.

#### **Old House Resources**

#### **Old House Support Group**

Mr. Chirikos received a call from the owner of the House of Seven Gables. The owner said he was done with his remodeling and wanted to do some additional work on the front of the house. Mr. Chirikos asked him send him pictures and clarify what he wants do to.

#### **Victory Gardens**

Ms. Selpien submitted her report in writing and it is attached. She stated the deer fence has been approved. She asked the Commission for suggestions on how to get sponsors for the garden. There will be additional costs for the garden such as hoses for watering, paths, etc. The volunteers have asked for a storage bench to store garden tools.

Motion by Ms. Mack, seconded by Mr. Gervais to spend \$150 to pay for the materials for the County's victory garden.

Mr. Chirikos suggested raising the amount to \$200. Ms. Mack amended her motion to \$200. A Roll call vote was taken as follows: Ms. Brown: aye, Ms. Mack: aye, Mr. Gervais: aye, Ms. Collins: aye, Ms. Selpien: aye, Mr. Randall: aye, Ms. Doornbosch: aye, Mr. Greeley: aye, Mr. Chirikos: aye. Motion passes.

Ms. Selpien has been in contact with various garden centers about starting a "grow a row for our local food pantries" program. This would involve distributing posters to the garden centers and having a list of food pantries available to the public. She submitted artwork for the posters. The County will order card stock to print the posters.

#### Web Site

Ms. Doornbosch submitted her report in writing and it is attached to these minutes. She is changing some wording on the web site regarding meeting dates and adding information about historic preservation legislation with a link to the LPCI & IHPA. She also posted information on the victory garden.

Mr. Chirikos received an e-mail from Grace Moline from the McHenry County Historical Society. She stated she was having a problem with the *contact us* e-mail link on the website. He contacted the web provider and they will be updating the current server.

#### **Scenic Roads Subcommittee**

Ms. Doornbosch spoke to the Bull Valley Village Clerk about nominating Fleming Road as a scenic road. The County is proposing to widen Fleming Road and she believes this is the motivation behind the nomination. She thought it would be nice if a loop route could be done hooking up the current scenic road Mason Hill to Fleming Road.

#### **Report from MCCD**

Ms. Brown reported the Oak Keepers study from 2009 has been tabulated. Oak Keepers are people who are trained to go to private owner sites that have a block of native oak trees. They found a property that has swamp white oaks off of Deerpass Road. The Oak Keepers mission is to educate homeowners on how to best care for the trees.

#### **Report from Staff**

Ms. Wanaski thanked the Commission for attending the 2030 Plan public meeting last month. She asked that annual reports be submitted this month. She mentioned the Walkup house, a Historic landmark, is in for permitting due to a fire. They are currently working the interior rehab.

#### **New Business**

Mr. Greeley stated the National Trust has a grant with a deadline of June 1st that the Commission will be eligible for to be used for brochures for the community guide. This is a true matching grant so we would need matching funds from the County which would amount to \$1250.

Ms. Doornbosch asked if the Commission was going to do a resolution supporting the Landmark Preservation Bill. Mr. Chirikos said he would research this and report back next month to the Commission.

Ms. Doornbosch asked about the cost of the meeting at the Dole Mansion being held on June  $18^{th}$ . The registration cost is \$30.

Motion by Ms. Brown, seconded by Ms. Collins that if Commission members want to attend the June 18th meeting at the Dole Mansion, the fees for the meeting will be paid by Commission.

#### Call to Order

Ms. Doornbosch called the meeting to order at 7:08 p.m.

Ms. Wanaski introduced Mr. Young. Mr. Young spoke to the Commission members about establishing a dialog with them regarding projects that the Division of Transportation (MCDOT) is working on.

Mr. Chirikos arrived at 7:14 p.m.

Mr. Young stated his division is most interested in historic properties that are adjacent to County highways. When the Division of Transportation does a project they go through a clearing house via the state and the State, through the Illinois Department of Natural Resources, looks for endangered species, etc. as well, as the having the Historic Preservation Officer (SHPO) sign off on the project. If there is a property registered as historic at the County level, it does not necessarily mean it is registered at the state level. Ms. Wanaski suggested that when the Transportation Division requests clearance from the state, they send a copy of the request to the Commission at the same time. She also said she would speak to the County's Stormwater Engineer to request the Stormwater Commission consider a standing variation for historic properties when stormwater issues are raised due to road construction projects.

Mr. Young stated MCDOT has a five-year transportation plan on their website that the Commission can view and bring any concerns to MCDOT'S attention. Ms. Wanaski stated she will add Mr. Young to the Commission's mailing list so he will be aware of what the Commission will be discussing at their meetings. He will also be added as an ex-officio member of the Commission. She asked Mr. Young to add her to the list to receive MCDOT meeting packets as well. The Commission thanked Mr. Young for his time and noted they look forward to a productive working relationship.

Ms. Conley introduced herself to the Commission. She submitted a preservation trades resource list to the Commission. The list was compiled from Joint Council members who suggested contractors or a tradesperson who they have worked with who they would recommend. Tradesmen have also asked to be placed on the list through a response to a press release. The State's Attorney has approved the disclaimer on the website stating the list is a compilation of referrals only and not recommendations. The list will be updated periodically. As such, the list can be posted on the McHenry County Historic Preservation website.

Again, the Commission thanked Ms. Conley for her work.

#### **Approval of Minutes**

Motion by Ms. Doornbosch, seconded by Mr. Greeley to approve the minutes of the April 7, 2010 McHenry County Historic Preservation Commission. All members present voting aye. Motion carried.

#### **Chairperson Report**

Mr. Chirikos submitted his report in writing and it is attached to these minutes. He expressed his anger and sadness over the demolition of Grace Hall which is located in the City of Woodstock.

#### **Standing Committee Reports**

#### Survey

Mr. Randall submitted his report in writing and it is attached to these minutes. He spoke with Mrs. Endres who owns Alden Mill. She would like to nominate it for land marking. There was an issue with the parcel identification number but that has been resolved. Mr. Randall submitted photographs of the property. There is remodeling in progress at the house and some of the work is not sympathetic to the historic nature of the house. Ms. Endres has installed sliding glass doors and skylights. Ms. Brown stated the Commission should create an initial report based on discussion and photographs viewed at the Commission Meeting, it is the Survey Committee's recommendation they do not pursue land marking due to the alterations that have affected the historic integrity.

Mr. Randall received pictures of the Jadd barn on Flemming Road. He just received the packet and has not had an opportunity to review it. He will report on the Farm at the next meeting.

There was a brief discussion on how the Rural Intensive Survey is organized and carried out by the Commission.

Ms. Wanaski explained she will be moving into a new position in the department. She will work in the CDBG Division in charge of grants and state funding. She will be the liaison in name only until the end of the year. In her absence Mr. Foley may act as the liaison.

#### **Approval of Minutes**

Motion by Mr. Gervais, seconded by Ms. Selpien to approve the minutes of the May 5, 2010 McHenry County Historic Preservation Commission. All members present, with one abstention from Mr. Gervais, voting aye. Motion carried.

Mr. Chirikos introduced Mr. Michael Walkup. He is the owner of one of the County's historic landmarks which recently had a fire. He wanted to let the Commission know what was happening with the reconstruction. He said the house has been gutted and this presents an opportunity to look at the structural aspects of the house. A new 2x4 frame structure will have to be built inside the stone walls. There are certain things the County will not do because they would result in code violations. One example is the 2<sup>nd</sup> floor windows. They are not up to current code. Mr. Gervais reminded Mr. Walkup about obtaining a Certificate of Appropriateness. Mr. Chirikos suggested videotaping the restoration.

After discussion, Mr. Walkup invited the Commission to his house to do a walk through. The Commission agreed to visit the property on June 7th at 5:00. Mr. Chirikos will get information on tax credits for historic houses for Mr. Walkup and the Commission will compose a letter requesting drawings from the architect.

#### **Chairperson Report**

Mr. Chirikos submitted his report in writing and it is attached. He stated that following last month's meeting in which Mr. Jeff Young attended, some of the Commission members were contacted by residents of Fleming Road where MCDOT is proposing an improvement

project. He said some residents are under the impression that if they landmark the road, it will prevent this work. Mr. Chirikos read a statement in which he stated "creating landmarks for the purpose of disturbing the purpose of another County department should not be a function of the Commission."
