### Call to Order

Chairman Collins called the meeting to order at 7:05 p.m.

Ms. Selpien introduced herself to the Commission members that were absent last month. She would like to fill the vacancy on the Commission.

Ms. Duresa stated she had a point of information and proceeded to ask the Commission about Certificates of Appropriateness regarding the Hutchinson House that were e-mailed to her. She said she did not understand and, in her opinion, she felt they were not completely filled out. Commission members told her that the owners came to the meeting in October and the certificates were completed in the Commission's presence. After some debate, Ms. Otis stood up and announced she was submitting her resignation. Ms. Duresa also submitted her resignation.

Ms. Duresa, Ms. Otis and Ms. Scherschel left the meeting at 7:15 p.m.

## <u>Approval of Minutes</u>

Motion by Ms. Brown, seconded by Mr. Gervais to approve the minutes of November  $5^{\rm th}$  2008. All members present voting aye. Motion Carried.

## **Election of Officers**

## Election of Chairman

Motion by Ms. Mack, seconded by Ms. Brown to nominate Mr. Chirikos as Chairman. There were no other nominations. All members present voting aye. Motion Carried.

Motion by Ms. Brown, seconded by Ms. Collins that the Commission continues the elections with the new chairman presiding. All members present voting aye. Motion Carried.

Mr. Chirikos expressed his gratitude to Ms. Collins for her past service as Chairman of the Commission.

#### Election of Vice Chairman

Motion by Ms. Collins seconded by Mr. Gervais to nominate Ms. Brown as Vice Chair. There were no other nominations. All members present voting aye. Motion Carried.

#### **Election of Secretary**

Motion by Ms. Brown, seconded by Mr. Gervais to nominate Ms. Mack as secretary. There were no other nominations. All members present voting aye. Motion Carried.

## Standing Committee Reports

#### Survey

Mr. Chirikos recommended Ms. Brown continue on the Survey Committee. Ms. Brown stated she would maintain that position.

#### Municipal Liaison

Mr. Chirikos recommended that Ms. Mack and Mr. Gervais continue to serve as the municipal liaisons. Ms. Mack and Mr. Gervais stated they would be happy to continue in that capacity. Ms. Mack stated there were over 200 people at the Lincoln presentation at McHenry County College. She said it went very well.

Ms. Mack mentioned a program called <u>Hats off to you, Mr. Lincoln.</u> She asked the Commission if they would like to decorate a hat. The Commission agreed to decorate a hat with the theme of the "debater." Ms. Wanaski said she would ask the Planning and Development Department if they would like to decorate a hat.

#### Old House Support Group

Mr. Chirikos said he would like to continue on this committee.

#### Communications/Education

Ms. Collins stated she was responsible for communications when she worked on the Commission's web site. She is more involved in the education portion of the committee. She would like to continue with the Gazette and work on launching the Heritage Oak Program for history month in May.

Motion by Ms. Brown, seconded by Mr. Gervais to split the Communications/ Education Committee into two separate committees with education continuing with its sub-topics and communication being its own committee. All members present voting aye. Motion Carried.

Ms. Collins will continue working on the Education Committee which will include the Gazette and the Oak Program, and Mr. Chirikos will continue to work on the Communication Committee which will encompass the website.

#### Scenic Streets and Roads

Ms. Mack volunteered to work on streets and roads until someone is able to fill the vacancy. Ms. Collins said she is willing to help Ms. Mack if the need arises.

#### **Program Coordinator**

Ms. Mack stated she usually coordinates programs, such as scenic roads and land markings. The Commission acknowledged it is a valuable function but not as its own committee.

Motion by Mr. Gervais, seconded by Ms. Mack to eliminate the title of Program Coordinator as a standing committee and relocate it under municipal liaison functions. All members present voting aye. Motion Carried.

## Report from MCCD

Ms. Brown stated there is a Quercus Project for the County which is made up of homeowners and groups of volunteers they call oak keepers who survey parcels. There has been a new oak species found in McHenry County that has never been recorded called the Swamp White Oak. These naturally occurring Swamp White Oaks have been found north of Marengo Ridge just north of Deerpass. Another area of these oaks was found at the north end of Chemung Township.

Ms. Collins mentioned she has a preview of a presentation called the Oaks of McHenry County that may be televised in the future on public television. Mr. Gervais suggested putting that as an agenda item next month under Education.

Ms. Brown wanted to clarify something that was written in Ms. Otis' resignation letter. She stated she is not an ex-officio member of the Conservation District. She is an employee of the District and is a full voting member of the Commission.

## Report from Staff

Ms. Wanaski stated it is annual report time. She distributed the attendance chart for last year. She stated Catherine O'Connor will allow the Commission to send the annual report digitally to IHPA. However, because Ms. O'Connor has many CLGs to review, we will only send the minutes of the public hearing for the designation of Chunn's Burying Ground. Ms. Wanaski reviewed the information she will be sending with the Commission. She stated the landmark list should be updated.

Mr. Sandquist addressed the Commission. He introduced himself to the Commissioners that were absent last month and stated the Planning and Development Department is committed to meeting supporting needs of the Commission as a group. He had conversations people from LPCI and IHPA about speaking with the Commission. Mr. Gervais felt that coming to the Commission may be more appropriate for a Joint Council meeting, this way all groups can benefit from their knowledge.

Ms. Brown stated she would like to publish the Commission's request for people to fill the vacancies in the local newspaper. Mr. Sandquist suggested a press release and he will speak with the Administrator's intern to see if that can be prepared.

Ms. Wanaski asked Ms. Mack if the Joint Council meeting could possibly be moved to April because of all of the Lincoln festivities going on. Ms. Mack will check and get back to the Commission. Ms. Wanaski asked the Commission to consider finishing the photographs of the last two landmarks which would be the gates and the cemetery.

Mr. Gervais mentioned that he appreciates the outstanding work that staff has done for the Commission. He said they have always gone out of their way and have acted professionally and are very dedicated.

#### New Business

Ms. Mack stated she would like to designate Lincoln Road in Chemung as a scenic road as a special project for the bicentennial.

Ms. Collins mentioned she would like to present her Community Character presentation to the County Board. Mr. Sandquist said he will speak to Mr. Austin.

Motion by Ms. Mack that the Commission sends Ms. Selpien's application to the Planning and Development Committee. Mr. Gervais noted a motion is not required. The application goes to the Planning and Development Committee with a memo and they forward it to the County Board. The motion was withdrawn. Ms. Wanaski asked Ms. Selpien for a short resume to be included with the application.

## Call to Order

Chairman Chirikos called the meeting to order at: 7:05 p.m.

## **Approval of Minutes**

Motion by Mr. Gervais, seconded by Ms. Brown to approve the minutes of February 4, 2009. All members present voting aye. Motion Carried.

Mr. Gervais introduced Mr. Randall. Mr. Randall submitted an application to the Commission to fill one of the vacancies. He works as a civil engineer and has a degree in architecture.

## <u>Chairperson Report</u>

Mr. Chirikos mentioned Ms. Duresa and Ms. Otis tendered their written resignations at the last meeting. A week later, Commissioner Scherschel submitted her resignation. Mr. Chirikos stated he wrote her and thanked her for her service. He welcomed Ms. Selpien as the newest member to the Commission. This leaves three vacancies on the Commission. The Commissioners discussed possible people to fill the vacancies. Ms. Wanaski informed the Commission that Kevin Craver a columnist with the Northwest Herald, published a notice in the Community section of the paper advertising that HPC is accepting applications for those vacancies. Ms. Wanaski will e-mail Mr. Craver asking if he can have the article run again.

## **Standing Committee Reports**

#### Rural Intensive Survey

Ms. Mack began the discussion by mentioning she spoke with Lisa Dichiera, of the Landmarks Preservation Council, who was under the impression the last survey was completed in 1980. Ms. Brown added, especially for the benefit of the newest member and guest that four townships were completed in 1998: Nunda, Grafton, Algonquin and McHenry. The intensive survey started in those townships most impacted by development issues. In 2003, Richmond, Burton, Dorr, Greenwood and Coral were completed. There are eight townships left to be done.

Ms. Brown would like to finish colating the second phase of the survey and have all of the data accessible in notebooks. Ms. Wanaski stated in the past the Planning and Development Department has asked the County for supplemental budget dollars to fund the survey and the Department has been denied those funds. The Commission discussed how to accomplish completing the survey. The survey would not start until next fall.

## <u>Municipal Liaison</u>

Ms. Mack submitted her report in writing. The next Joint Council meeting will be held on April 29th at the Frank Howard Estate. Lisa Dichiera, of the Landmarks Preservation Council, has been tentatively scheduled as the speaker. The Bicentennial Committee Gala was successful and the Hat's Off to Lincoln Display was showcased. It is available for display to other organizations and hopefully will have a permanent home at the Government Center.

Mr. Chirikos said he has been talking to Ben Wellington, of Planning and Development, about posting information about the support group on the HPC's website.

## Communications/Education

Ms. Collins presented the Oaks of McHenry County video to the Commission. There are negotiations with public television to air the program. After the video, Ms. Collins stated she would like the Commission to formally launch the Heritage Grove program to raise the public's awareness. She suggested a PowerPoint presentation or graphic display be part of the April 29th Joint Council meeting.

Ms. Collins said the next issue of the Gazette will be published for "History Month" in May. If the Commission has any suggestions or submissions she would like them by mid-April.

Ms. Wanaski asked Ms. Mack if she would consider putting up a sign at the Joint Council meeting that would illustrate new programs that the Commission is launching such as the Heritage Grove Program. The Heritage Grove Program was discussed. Ms. Wanaski showed the Commission samples of the signs. The Commission decided to have two copies of each sign made, one small and one large. Mr. Gervais asked if a grove was on private property, is the Commission going to require the landowner's approval first. After discussion, it was decided changes will be made to the application and a signature will be required from the landowner before the grove is recognized. The Commission will also follow up with a phone call to verify the

landowner's signature. The Commission decided to make two copies of each sign to bring to the Joint Council meeting next month along with copies of the heritage grove application.

#### Call to Order

Chairman Chirikos called the meeting to order at: 7:05 p.m.

## **Approval of Minutes**

Motion by Ms. Brown, seconded by Mr. Gervais to approve the minutes of April 23, 2009. All members present voting aye. Motion Carried.

Ms. Hill introduced herself as a County Board member and the Chairman of the Planning and Development Committee.

## Chairperson Report

Mr. Chirikos announced to the Commission that Bruce Randall's application was accepted by the County Board. The Commission will be reviewing additional applications tonight. There are four applicants for two available positions.

Mr. Chirikos asked Commission members to put together a short biography of themselves for the website and submit a photo.

Ms. Collins sent an e-mail to Mr. Chirikos suggesting she take a leave of absence or resign from the Commission due to a health issue. Commission members discussed the bylaws. There is nothing in the bylaws that addresses a leave of absence. If a Commission member informs the Commission they are unable to attend a meeting, it is considered an excused absence. Because nothing other than three unexcused are noted in the bylaws, the Commission suggested Ms. Collins notify the Commission each month when she will absent and return when she is feeling better.

## <u>Standing Committee Reports</u> Survey

Ms. Brown gave maps of Lincoln Road dating back to the 1800s to Ms. Mack to include in the Lincoln Road scenic road nomination.

Ms. Brown stated she received a quote on oak trees for the Lincoln Bicentennial Committee tree planting program. The plant ecologist recommended the Lincoln Bicentennial Committee use native oaks that actually came from McHenry County as opposed to going through an outside supplier. It was decided to buy a combination of white and burr oaks as suggested by Ms. Brown.

Ms. Brown submitted documentation regarding the demolition of several outbuildings at the Glacial Park Lodge Conference Center. The buildings are going to be demolished due to maintenance costs. The buildings consist of the caretaker house, the VIP quarters, a shed that was converted into a second caretaker quarters and the garage.

Motion by Mr. Gervais, seconded by Ms. Brown to recommend the McHenry County Conservation District approve the demolition of the four structures at the Glacial Park Lodge Conference Center. Mr. Chirikos voting nay, all other members voting aye. Motion passed with a five to one vote.

## **Municipal Liaison**

Ms. Mack attended the Joint Council meeting held on April 29th at the Glacial Park Conference Center. It was very well attended with over 40 attendees from various organizations. There were two speakers, Lisa DiChiera and Adam Kingsley from Landmarks Illinois. Lisa spoke on Landmarks Illinois work in McHenry County and other projects in Illinois and Adam spoke on the challenge to the Chicago Historic Preservation Ordinance.

Ms. Mack has been working with Tina Hill on a presentation regarding the Lincoln Oak Planting Program for the June meeting of the McHenry County Council of Mayors.

## Victory Gardens

Ms. Selpien reported that several garden centers participated in victory garden activities including *Countryside*, *Tom's Greenhouse* and *Kolze Garden Center*. On April 23rd, during each segment of the morning news on Star 105.5, Stew Cohen did a piece on victory gardens including a sound byte from Ms. Selpien. *Tom's Greenhouse* and *The Garden*, located on Route 31 in Crystal Lake are planting victory gardens. #### **Chairperson Report**

Chairman Chirikos welcomed the two newest members to the Commission; Steve Greeley and Trish Doornbosch. He stated that the Commission is looking forward to advancing the Barber Burying Ground Cemetery as the next landmark. He also mentioned the need for the Commission to apply for grant funds for the Intensive Survey and other projects. He is working with Ms. Mack and has begun speaking to state officials.

#### **Standing Committee Reports**

#### Survey

Ms. Brown's items are covered under other agenda items.

#### **Municipal Liaison**

Ms. Mack reported that she met with Ms. Doornbosch to discuss the Scenic Road Program. Ms. Doornbosch agreed to chair this subcommittee. Members of this subcommittee were contacted to schedule a get acquainted meeting. The meeting will be held on July  $8^{th}$  at 7:00 p.m. at Borders in Crystal Lake.

#### **Lincoln Bicentennial Program**

Ms. Mack and Tina Hill, County Board member, attended the McHenry County Council of Government's meeting and gave a brief presentation of the Bicentennial Oak Program. Brochures were passed out and a rock prototype marker was brought to the meeting. It was suggested there be a ceremony for each planting. Mr. Gervais noted that he liked the involvement from Ms. Hill and felt she is really committed to the Commission.

#### **Old House Resources**

#### **Old House Support Group**

Mr. Chirikos reported that the Rewoldt home repairs are on hold until funds are available.

#### **Victory Gardens**

Ms. Selpien reported that 300 plants were donated and ready for planting in a victory garden. She said she had requested Ms. Hill to have the tilling work done for liability reasons. Ms. Hill sent the requested to legal and it never returned. One of the main questions was who is responsible if someone gets hurt on County property. Ms. Selpien asked the Commission where they want to go with this. Mr. Gervais felt it would be next year if an actual garden would be planted. Ms. Selpien also mentioned that the master gardener program would like to help with this project. Ms. Wanaski suggested that the County has a landscaper and it could be requested that they could do the tilling for the victory garden. Chairman Chirikos asked if the Commission could facilitate this project without becoming involved in actual planting perhaps by providing the history and background on victory gardens, preparing a pamphlet, and including the information on the website.

Ms. Wanaski received a call from Jamie Sutherland, and she said that Ms. Sutherland would like to pursue a victory garden not-for-profit agency. Ms. Wanaski suggested she contact Tom Riley a senior grant writer for the Continuum of Care, which is an agency of all the service providers in the County. The main question was if townships could do this and use CDBG funds. Ms. Sutherland could come to the next meeting and will have her business plan completed. Mr. Gervais suggested contacting the master gardeners and inviting them to the next meeting as well. Ms. Collins said she agreed with Chairman Chirikos that the Commission should not be as involved by getting their hands dirty. This item is tabled until the August meeting where the Commission will listen to what Ms. Sutherland has to say. If this was to move forward it might provide public relations opportunities for the Commission. It was suggested to invite Ms. Hill to the next meeting. (No written report.)

#### **Communications/Education**

#### Oak Program

The Heritage applications were provided to the Commission. Ms. Collins mentioned that she knows of many oak groves and will fill out applications to submit at the next meeting. Once submissions are made, volunteers will be needed to contact property owners. She felt this would be a big undertaking.

Ms. Brown brought a map that was created by Ben Haberthur of MCCD. The map included layers created by the Morton Arboretum. The map is digitized and has the locations of witness trees from the 1837 survey. The trees are categorized on the map by the type of tree. The GIS specialist at MCCD has a copy of the layer of this map. She said all that needs to be done is to go to the site and see if the tree still exits. Ed Collins from MCCD needs to be persuaded into printing the rest of the map. Ms. Brown said she did not have the time to investigate all the trees. Chairman Chirikos suggested putting this on the website and could ask the public if any of the trees are on their property or if they know of any of the trees. It could be a contest or a campaign.

#### Gazette

Ms. Collins will start working on the Gazette. Mr. Gervais felt it was important to continue with the Gazette to reach out to children about the County's history and heritage. It was decided that the Gazette will remain in a paper form, but also be provided in a digital format.

#### Scenic Roads

Ms. Collins mentioned that she, along with Ms. Brown, thought Tryon Grove Road from the Richmond High School to Route 47 is something to look at and should be a scenic road. There are horse stables, well renovated and preserved historic house, historic cemetery and the first County landmark which is Tryon Grove Farms. Nominating Tryon Grove Road and Vanderr Karr Road would be 2 scenic roads through Richmond and Hebron Townships.

#### **Communications**

Chairman Chirikos reported that nothing further has been added to HPC website.

He contacted Diane McGowan regarding land marking her property known as the Haligus School. He will pursue the matter when she returns his phone call.

He received a bill from Traverse Global for the web hosting fee. There is also a domain name renewal. It is nearly \$130.00 per year. The Commission owns both mcchpc.com and org. He recommends dropping the .com and saving \$20 and also renewing on a 5-year basis. The Commission agreed and also would like to bring this to a local company. It was the consensus to go with a local county business. Mr. Sandquist said that since the Commission is paying for the name is there a need for someone to host this or can it go on the County's website. #### Call to Order

Chairman Chirikos called the meeting to order at 7:06 p.m.

#### **Approval of Minutes**

Motion by Mr. Gervais, seconded by Ms. Mack to approve the minutes of the August 5<sup>th</sup> 2009 HPC meeting. All members present voting aye. Motion carried.

Motion by Mr. Gervais, seconded by Ms. Collins to amend the agenda to allow Ms. Collins to present three slide shows. She presented Community Character, Remaindering of the Nippersink and the Oaks of McHenry County.

#### Alden Road/Bridge Project

Mr. & Mrs. Endres submitted a landmark application for the Alden Mill in Alden. Ms. Endres explained how the Alden Road and bridge project impacts her property. She said there are two projects, the Alden Bridge project, which consists of replacing the bridge and widening the road directly north and south of the bridge. MCDOT wants to widen the bridge 8 feet on each side and the shoulder along the road. The Mill is in the road right-of-way, and Ms. Endres said MCDOT has agreed to take it out of the right-of-way because it runs through her house.

The other project is the Alden Road project which encompasses all of Alden Road north and south of the bridge beyond the town. MCDOT wants to increase the right-of-way from 35 feet on each side to 60 feet on each side of the center line of the road. The 60-foot right-of-way will impact yards, trees and corners of buildings. MCDOT has agreed to meet with the residents regarding the 60-foot right-of way. The road project is in Phase 1 and it is on hold until next spring.

The Endres' live next to the bridge. The guard rail would go across their north driveway and they would lose access to their well. After Ms. Endres raised objection to that, MCDOT agreed to remove the guard rail once every ten years if they need access to their well. Their property goes to the middle of the road, and they own the property under the bridge.

Ms. Endres said MCDOT is taking an easement because a variance would not be valid. Where the right-of-way runs through her living room, MCDOT is going to do a jog around the building.

Ms. Wanaski stated the right-of way issue needs to be resolved before the Commission can proceed with the application because the HPC does not have landmarking privileges in the right-of-way. Once a new plat of survey has been filed, the Commission can then go forward. The Commission will keep the nomination application on file.

#### **Chairperson Report**

Chairman Chirikos submitted his report in writing and it is attached. He stated the Barber Burying Ground was recommended for landmark status and the County Board will vote on the nomination at the September 15<sup>th</sup> meeting.
