Some of the Commissioners dislikes are the new formality of the meetings, low participation at award ceremony's, complicated information that is distributed to the public and lack of public awareness. Lack of equal workload, no follow through, no discussion of committee reports at the meetings were also mentioned.

RECOMMENDATIONS

The Commission would like to see increased interest of public, a Fall tour of historic sites, more publicity, a focus on public education and more plaqueing of historic homes and buildings, historic pictures in government center, better communication between commission members. It was suggested that the next vacancy be filled by an architect, more interaction with the Historical Society, identifying endangered sites, additional in-house education, a yearly goal and follow through and joint historic projects were also suggested.

- Gail Drabant commented that the Preservation Ordinance states that a Conservation District liaison be present at all meetings. There has been no representative present for months.
- Maryanne Wanaski suggested putting an ad in the newspaper to promote public awareness. Nancy Fike suggested community newsletters would also be helpful for advertisement.
- Nancy Fike suggested joining other types of groups that have an interest in County Development.
- David Gervais commented that Gail Drabant concentrate on Historic Preservation Awards. David suggested that Gail make a recommendation of members the Awards Road task force at the next meeting.

JUNE 6, 2001

I. CALL TO ORDER

Chairman David Gervais called the meeting to order at 7:00 p.m.

II. ROLL CALL and INTRODUCTION of GUESTS

Present: David Gervais, Denise Collins, Gail Drabant, Jennifer Iftner, Carrie Koster-Horan, Gloria Mack and Michael Walkup. It was noted that Michael Walkup arrived at 7:14 p.m.

Guests: Paul W. Ostrander – Huntley Park District, Jerry W. Nepermann – Huntley Park District and Charles Yerke – President, Huntley Park District

A. QUESTION and ANSWER PERIOD RELATED TO DEICKE FARM APPLICATION

A motion made by Gail Drabant, seconded by Gloria Mack to suspend Roberts Rules. All aye. Motion carried.

Guests from the Huntley Park District introduced themselves to the Commission. David Gervais acknowledged receipt of the packet the Park District presented to the Historic Commission in regards to the Deicke Sun Valley Farm, located at 12201 West Main Street, Huntley, Illinois.

Gloria Mack questioned the newer addition to the barn. The newest addition on the east end of the barn will be removed. Mr. Yerke, President of the Huntley Park District said that lumber would be saved from the addition and will be reused. It is speculated that the main barn was built in the early 1840's. The second addition was added around the late 1870's. The newest addition was added in the early 1900's.

Gail Drabant commented that an official application must be completed and submitted before evaluation of the property can be made. Gail asked if all buildings on this site were to be considered for landmarking.

Mr. H. Stowell was the original owner of the property. It was noted that the National Registry prefers using the original owner's name for landmarking. Mr. Edwin F. Deicke purchased the property at a later date. He purchased 5 (five) additional farms which bore the name of "Sun Valley Farms". Mrs. Edwin Deicke sold land from the farm to the Huntley Park District which is being now used as a learning center. Approximately in the early 1850's a house was built around the original log cabin. The basement shows that original construction of ceilings were logs. It is

rumored that slaves were hidden in the small concealed rooms on the second floor during the time of the Underground Railroad. Gloria Urch, Founder of the Underground Railroad Museum and Ethnic Emporium, could not confirm that the house was ever used for that purpose but did comment that it was possible.

Carrie Koster-Horan voiced concerns regarding the name of farm. Park representatives explained that it has always been called the Sun Valley Farm among local residents.

Jennifer Iftner commented that landmarking of the whole farm is a good idea, but the barn should be considered first.
