Representatives from the Village of Huntley attended the meeting to discuss the preservation of Woodstock Street. Sue Lamb, a Village Board member, stated that on September 24, 1998 the Village sent a letter from Mayor James Dhamer to Gail Drabant indicating the Village's interest in formulating an intergovernmental agreement with McHenry County. It would be a similar agreement with the Village and adopting the County's Historic Preservation Ordinance. Woodstock Street is in need of repair/replacement; it was originally constructed in the early 1900's. The bids to repair the street have been received (\$335,000.00 to \$353,000.00). The funding is the largest concern of the Village at this time. McHenry County would have to recognize Woodstock Street as a landmark before an application can be submitted to IDOT for enhancement funding.

David Gervais stated that there is a list of criteria that must be adhered to. It was suggested that the Cary ordinance could be followed with certain modifications. Maryanne Wanaski stated that she spoke with Springfield and they stated Huntley would only qualify if they would adopt the McHenry County Historic Preservation Ordinance.

Gloria Mack made a motion that the Village of Huntley proceed in an appropriate manner towards entering into an intergovernmental agreement with McHenry County with approval of our legal council seconded by David Gervais. There was a roll call vote with all members voting aye. Motion carried unanimously.

The Huntley delegation stated that a temporary binder cover will be placed over the street during the winter for safe driving conditions. The Village engineer assured them that it would not harm the bricks. Susan Lamb commented that original bricks would be removed and placed in other areas of Huntley. Gloria Mack suggested that the original bricks should be used in the reconstruction of the street.
